**MEMORANDUM OF UNDERSTANDING
BETWEEN
THE ASIA PACIFIC NETWORK INFORMATION CENTER (APNIC)
AND
UNIVERSITI SAINS MALAYSIA**

Parties

This Memorandum of Understanding (MoU) is made between:

A. APNIC Pty Ltd ACN 081 528 101 for and on behalf of the Asia Pacific Network Information Centre (**APNIC**);

and

B. Universiti Sains Malaysia, represented by National Advanced IPv6 Centre (Nav6)

Background

1. APNIC functions as the Regional Internet Registry for the Asia Pacific, in service of its members and the wider community. Whereby Nav6 is an advanced IPv6 excellence centre established by Universiti Sains Malaysia.
2. APNIC and Nav6 both perform critical roles within their own communities which support capacity building for the growth of an open, secure, stable Internet.
3. APNIC and Nav6 also organize diverse but related activities focused on education, training, and community events.

Objectives

4. Many activities of APNIC and Nav6 are complimentary, in terms of common or closely related audience, subject matter, locations and objectives.

5. APNIC and Nav6 are committed to working together in complimentary activities wherever possible and appropriate, to enhance cooperation towards their individual and shared objectives.

Record of Understanding

6. APNIC and Nav6 agree to cooperate to promote domestic and international Internet, standards, infrastructure development and services in order to encourage Internet development in Malaysia.
7. APNIC and Nav6 agree to exchange information regularly and render mutual assistance with regard to activities undertaken on behalf of their respective members in the Region and within the normal parameters of their organization activities.
8. APNIC and Nav6 agree to cooperate and render mutual assistance and reciprocate the attendance of their members to meetings, seminars, or conferences to further the goals of this MoU.
9. APNIC and Nav6 agree to cooperate and render mutual assistance and reciprocate the attendance of their members to training programs. Nav6 will encourage its faculty and students to attend training seminars developed and coordinated by APNIC training in Malaysia.

No transfer of funds

10. This MoU contemplates no transfer of funds between the Parties. In the event this document is terminated, each Party is solely responsible for the payment of any expenses it has incurred.

Status of this document

11. The parties record their mutual intention that this document serves as a non binding record of their understanding.
12. This document does not create any enforceable obligations under law.

Duration and amendments


13. This MoU supersedes and replaces any and all previous understandings between the Parties.

15. This MoU is intended to be long-standing. However, either Party may, by giving at least 60 days' notice in writing to the other party, terminate this MoU.
