What is APNIC?

- Regional Internet Registry (RIR) for the Asia Pacific region
 - One of five RIRs currently operating around the world.
 - A membership-based, not-for-profit organization
- Industry self-regulatory body
 - Open
 - Consensus-based
 - Transparent






Rationing the 'last block'

- APNIC's last remaining block is 103.0.0.0/8
 - Equal to 16,777,216 addresses
- Each member can only get up to 1,024 addresses (/22)
- Allows new members to get a little bit of IPv4 before it completely runs out

IPv4 Last /8 Delegations




IPv4 address transfer

- Transfer is allowed through:
 - Merger & Acquisition
 - Needs based market transfer
- Needs based market transfer
 - The recipient (or buyer) must show evidence of need before a transfer can be registered by APNIC
 - Policy designed by the community to prevent hoarding

Recycling returned IPv4 address space

- Address space returned to IANA will be re-distributed equally to all 5 Regional Internet Registries
 - Estimated to happen in May
 - prop-105: Distribution of returned IPv4 address Pending implementation
- The re-distributed space received by APNIC will be rationed like the 'last block'
 - A member can only get up to 1,024 addresses (/22) from recycled pool

IANA Oversight Transition

- October 2013: Internet's technical organizations signed Montevideo Statement calling for globalization of ICANN and IANA functions
- January 2014: APNIC EC endorsed statement
- March 2014: US government announced IANA functions will be transferred to global Internet community
- Open community discussion process on IANA transition underway
