



Memorandum of Understanding between APNIC and SLNG

Date

10 February 2015

Parties

This Memorandum of Understanding is made between:

- A. APNIC Pty Ltd ACN 081 528 101 for and on behalf of the Asia Pacific Network Information Centre (APNIC); and
- B. Sri Lanka Next Generation (SLNG)A local body of Sri Lanka for the Asia Pacific Next Generation

Background

- 1. APNIC functions as the Regional Internet Registry for the Asia Pacific, in service of its members and the wider community. SLNG is a local body of APNG to promote and create awareness of Internet and ICT activities in Sri Lanka.
- 2. APNIC and SLNG both perform critical roles within their own communities which support the growth of an open, secure, stable Internet.
- 3. APNIC and SLNG also organize diverse but related activities focused on outreach, training, community events, and fellowships.

Objectives

4. Many activities of APNIC and SLNG are complimentary, in terms of common or closely related audience, subject matter, locations and objectives.

5. APNIC and SLNG are committed to working together in complimentary activities wherever possible and appropriate, to enhance cooperation towards their individual and shared objectives.

Record of Understanding

- 6. APNIC and SLNG agree to cooperate to promote domestic and international Internet, standards, infrastructure development and services in order to encourage Internet development in Sri Lanka.
- 7. APNIC and SLNG agree to exchange information regularly and render mutual assistance with regard to activities undertaken on behalf of their respective members in the Region and within the normal parameters of their organization activities.
- 8. APNIC and SLNG agree to cooperate and ender mutual assistance and reciprocate the attendance of their members to meetings, seminars, or conferences to further the goals of this MoU.
- 9. APNIC and SLNG agree to cooperate and render mutual assistance and reciprocate the attendance of their members to APNIC training programs. SLNG will encourage its members to host training seminars developed and coordinated by APNIC training in Sri Lanka.

No transfer of funds

10. This document contemplates no transfer of funds between the parties. In the event this document is terminated, each party is solely responsible for the payment of any expenses it has incurred.

Status of this document

- 11. The parties record their mutual intention that this document serves as a non-binding record of their understanding.
- 12. This document does not create any enforceable obligations under law.

Duration and amendments

- 13. The parties can modify this document by recording any such modification in writing signed by both parties.
- 14. This document is intended to be long-standing. However, either party may, by giving at least 60 days' notice in writing to the other party, terminate this document.
