



# Memorandum of Understanding between APNIC and IDNOG

Date

29 JUN 2022

#### **Parties**

This Memorandum of Understanding (MoU) is made between:

- A. APNIC Pty Ltd (ACN 081 528 101) for and on behalf of the Asia Pacific Network Information Centre (APNIC); and
- B. Indonesia Network Operators' Group (IDNOG).

## **Background**

- 1. APNIC functions as the Regional Internet Registry for the Asia Pacific, in service of its members and the wider Internet community in the region.
- 2. IDNOG is an independent and not for profit organization. It is a community effort from volunteers. IDNOG was setup under an initiative to get together all network operators in Indonesia to share experiences, work together and learn from one another.
- 3. APNIC and IDNOG both perform critical roles within their own communities which support the growth of an open, secure, stable Internet.'
- 4. Many activities of APNIC and IDNOG are complimentary, in terms of common or closely related audience, subject matter, locations and objectives.

## **Objectives**

5. APNIC and IDNOG are committed to working together in complimentary activities wherever it's possible and appropriate, to enhance cooperation towards their individual and shared objectives.





#### **Record of Understanding**

- 6. The parties agree to work collaboratively to enhance their coordination and cooperation with regard to activities in which they have a common interest. Such activities may include:
  - a. Capacity building
  - b. Deployment of RPKI/ROA/ROV, IPv6 and DNSSEC
  - c. Infrastructure development (IXP, rootserver, etc.)
  - d. Surveys
  - e. Meetings and conferences
  - f. Community development
- 7. The parties shall work together to define the parties' goals, objectives, resource commitments, timelines and other related information, in relation to each agreed activity.

## No partnership or agency

- 8. This document does not create any partnership, agency, association, employment, or any other fiduciary relationship.
- 9. This document does not give any party, any authority to act as agent for, or on behalf of, or to represent or bind the other party in any manner.

#### No transfer of funds

10. This document contemplates no transfer of funds between the parties. In the event this document is terminated, each party is solely responsible for the payment of any expenses it has incurred.

#### Status of this document

- 11. The parties record their mutual intention that this document serves as a non-binding record of their understanding.
- 12. This document does not create any enforceable obligations under law.

#### **Duration and amendments**

- 13. This document replaces and supersedes the Memorandum of Understanding entered into between APNIC and IDNOG on 27 July 2017.
- 14. The parties can modify this document by recording any such modification in writing signed by both parties.
- 15. This document is intended to be long-standing. However, either party may, by giving at least 30 days' notice in writing to the other party, terminate this document.
