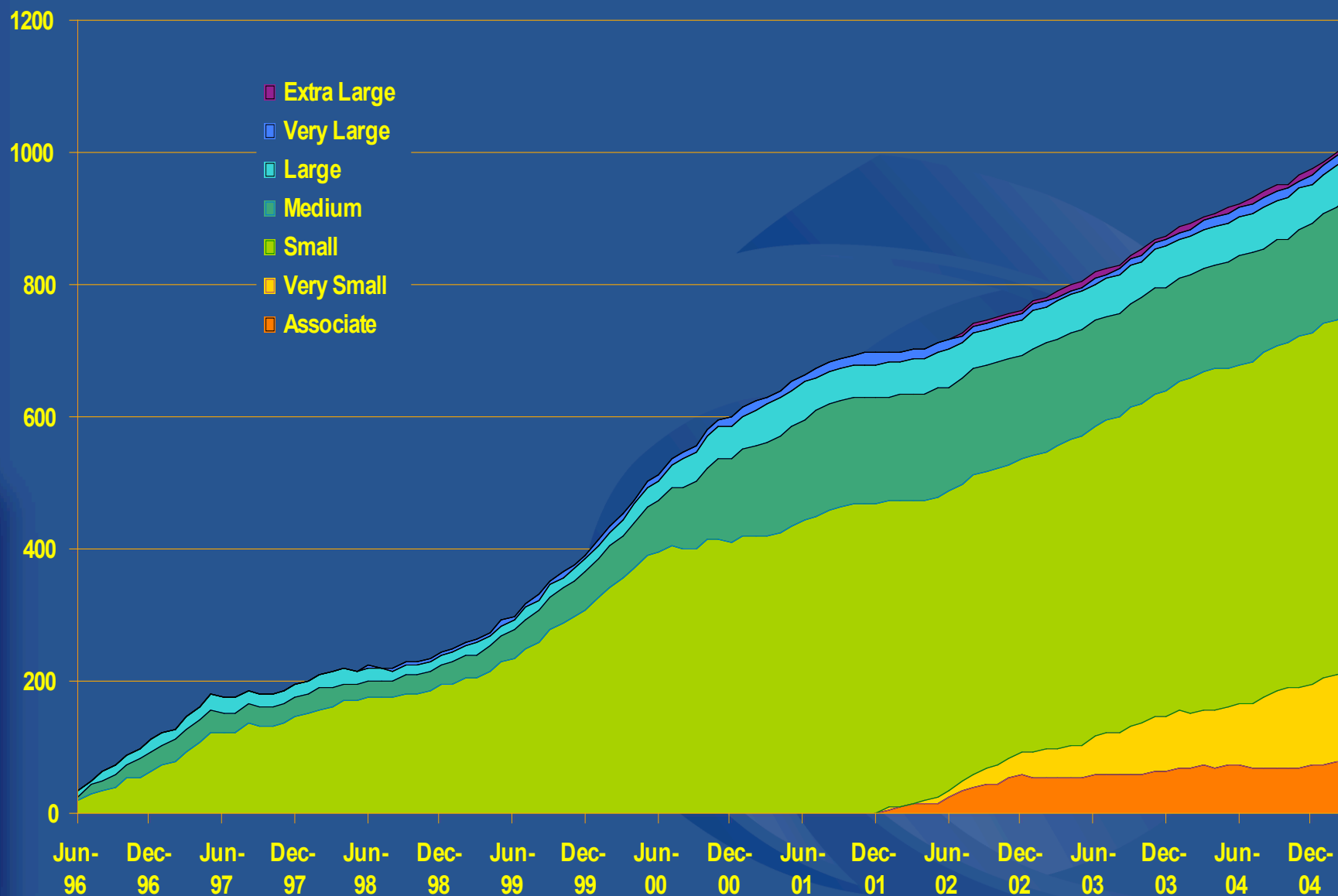
About APNIC

About APNIC

- Company registered in Australia (1998)
 - Non-profit constitution
 - Bylaws describe “APNIC” as “special committee”
- Taxation status
 - Not a charity
 - Company profits are taxable
 - But member funds not taxable (“mutual”)
- Financial policies
 - Annual audit (voluntary)
 - 1+ year budget maintained in reserve
 - APNIC EC (BoT) approves annual budget

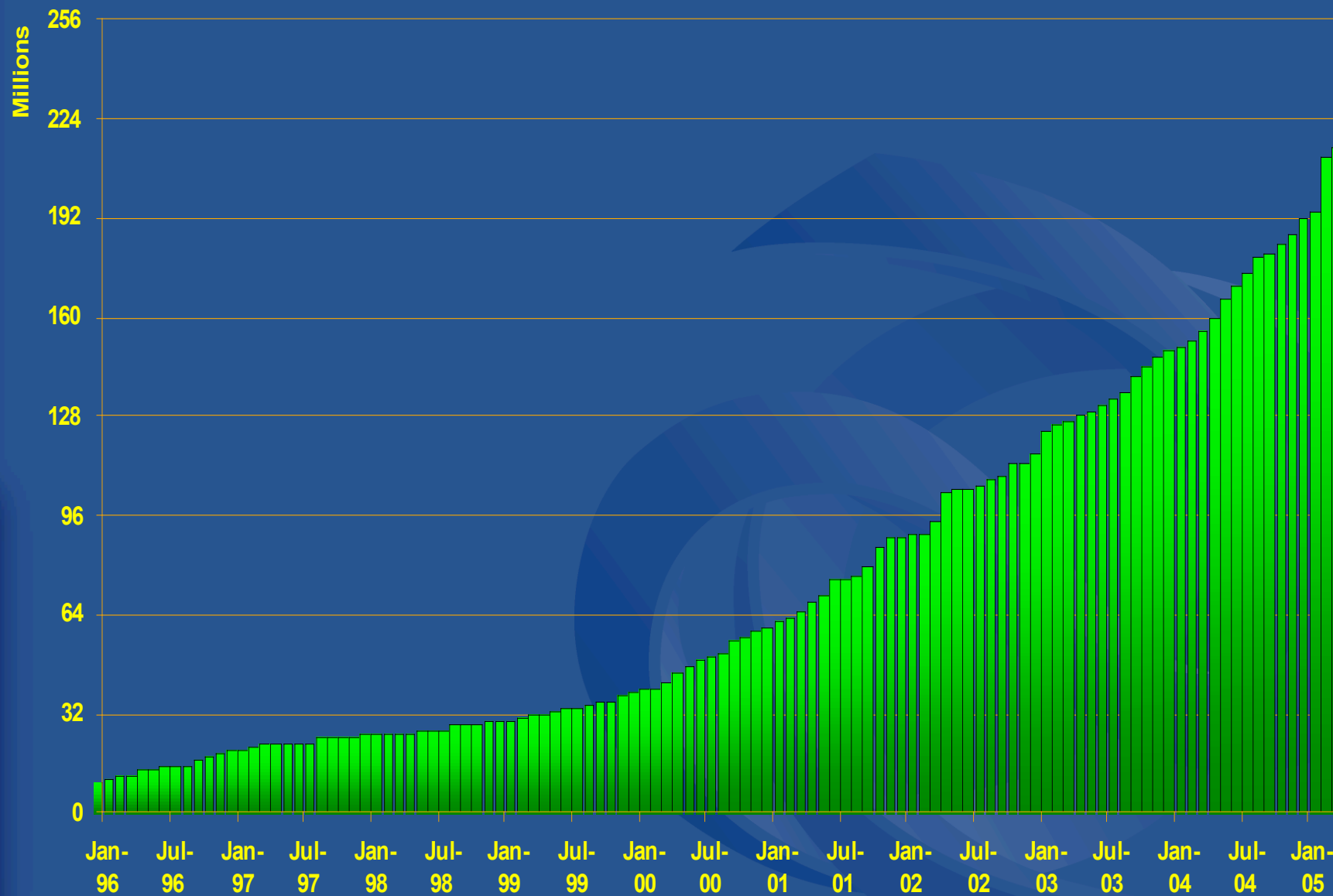

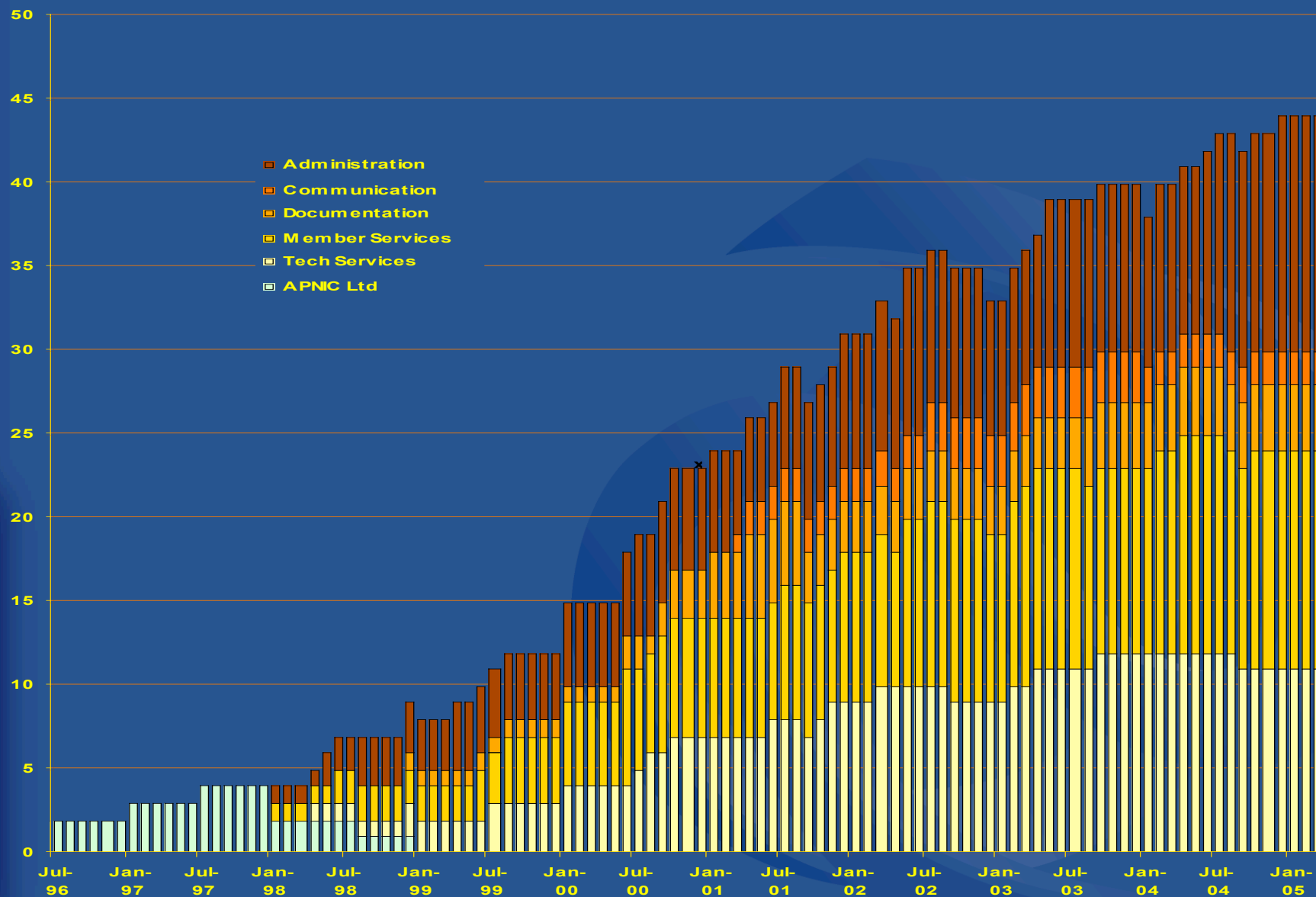


IPv4 allocations



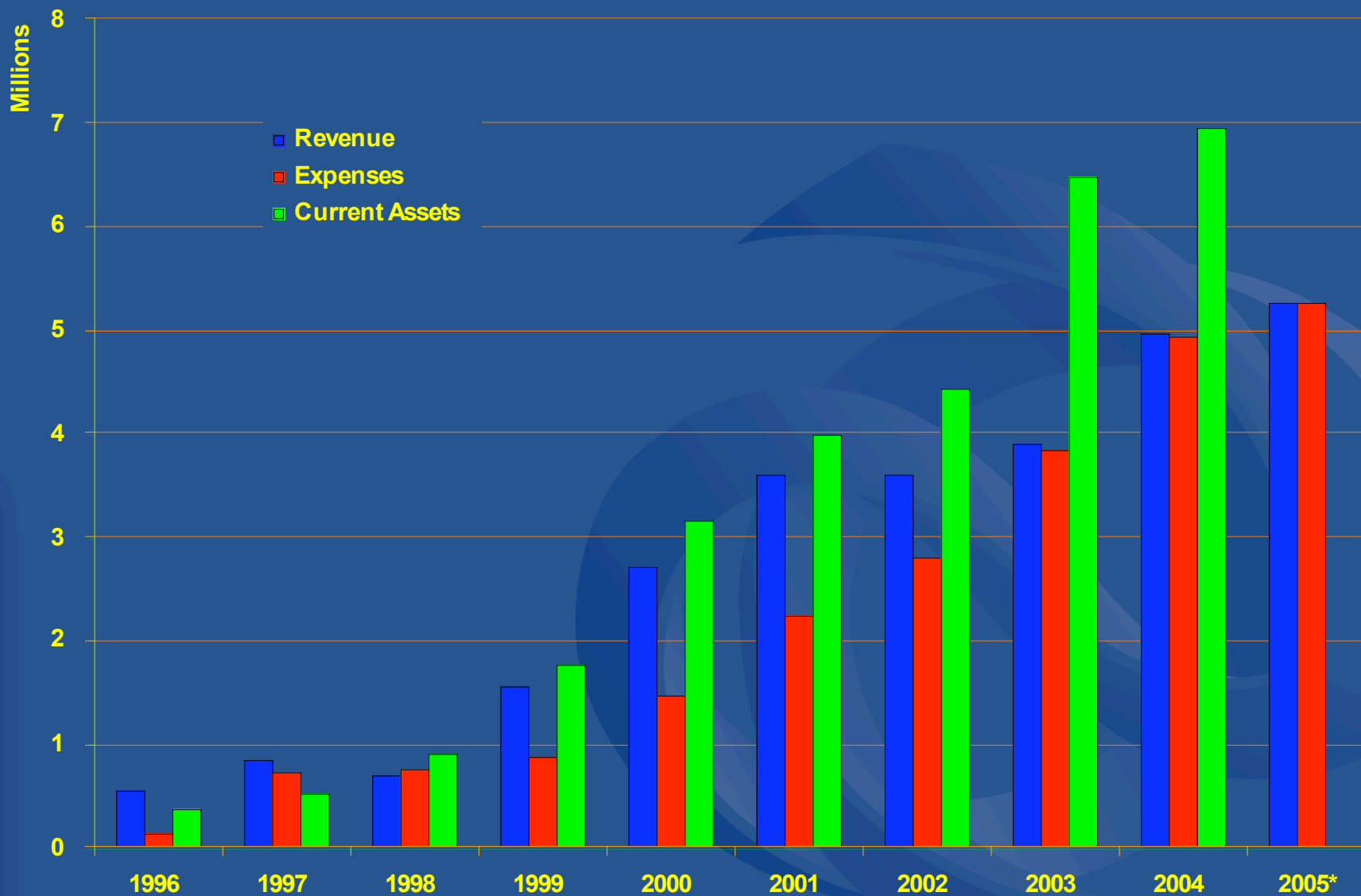

- APNIC member survey
 - 3 surveys so far: members & stakeholders
 - Major driver for activity planning and direction
 - Independent consultant, confidentiality assured
 - <http://www.apnic.net/survey>
- Planning process
 - Annual budget and forward plan
 - Approved by APNIC EC (BoT)
 - Internal (staff) “Strategic Plan” - 6 mo cycle

Selected activities

- New member/community services
 - MyAPNIC developments
 - ISP support website
 - VOIP access to helpdesk (coming soon)
 - Resource certificates RFC 3779 (secure BGP)
- New training activities
 - DNS, Routing, IPv6, Spam and Security
- “Governance” activities
 - Many of these: WSIS, WGIG etc

Rootservers

- ‘Anycast’ root server deployments
 - Working with root operators (F, I, K, M)
 - Work in progress
 - AU (K), (I), JP (K), IN, SG, KH, PK, CN
- APNIC PoPs
 - Reliable distributed services AU, JP, HK
